

# **2021 Huron Valley Marching Band Camp Covid Protocols and Procedures Statement**

The following procedures will be implemented for the 2021 Huron Valley Marching Band Camp at Blue Water Campgrounds, August 6 – 13, 2021:

## **Check-in:**

- For camp check-in on August 6, a parent will be required to check their student in and sign off documentation indicating their student, to the best of their knowledge, is free and clear of any symptoms associated with COVID-19.
- We will require a signed document stating the same information for all adult volunteers and band camp staff.
- We will have this documentation for each student/adult on file at camp.

## **Daily Procedure:**

- Each morning, prior to breakfast/start of day, temperature checks will be conducted for all camp participants. Temperatures will be recorded. Records will be properly disposed of after the conclusion of band camp.
- The camp health officer (nurse), Amy Cubbin, will monitor and evaluate students daily, and will notify Mr. Green immediately should a student/adult present any symptoms that could potentially be related to COVID-19.
- If a participant at camp shows any symptoms related to COVID-19, they will be quarantined (we have 4 designated buildings/areas at camp used solely for this purpose and no other use during our camp). If they are a student, we will immediately contact a parent and make arrangements for the student to be taken to a facility to be tested. Adults will be required to be tested as well.
- No participant will be allowed to return to camp unless test results are negative.
- Current protocols for COVID-19 quarantine will be followed should a test come back positive.
- Masks are optional at camp.
- Hand Sanitizer and wipes will be readily available to all camp participants, and they will be utilized prior to every meal.
- All commons areas (dining hall, restrooms) will be disinfected and cleaned daily.

## **Contact Tracing/Positive Cases:**

- In the event that a camp participant tests positive for COVID-19 while at camp, Mr. Green will notify the local health officials (Sanilac County), Blue Water Campgrounds Administration, and Huron Valley administration immediately.
- Information regarding a positive case will be reported to the families through HVS Administration/Mr. Green, to ensure proper communication at all times.

**Expectations of students and staff/volunteers in order to limit the spread of COVID-19:**

- Good hygiene practices (frequent hand washing) should be followed at all times.
- Sharing of mouthpieces, other equipment is expressly prohibited.
- Sharing of food and beverages is strongly discouraged.
